From the desk of Tom Page...

As most of you are aware, we are transitioning over the management of the homeowner's association from Associa/Community Group to Goodman Management Group. The official start date for Goodman is January 1, 2022, but the transition process is already underway. We'll try and make the transition as seamless as possible for owners, but there will be some minor changes. If we don't already have your email address, please register with Goodman so you'll be included in future communications regarding the transition. Also, I'd like to thank Denez Stabler, Patricia Velez and Hanah Watkins with Community Group for their efforts over the years managing the association.

From a development standpoint, we recently completed 53 new townhome lots in *Palisades Cove – Phase 1* and HHHunt Homes will be starting construction of their new model homes shortly. *Charleston Club – Phase 3*, which includes 49 lots and a bridge across Blackman Creek, and *Glen Abbey – Phase 2*, are both coming along nicely and will be complete early next year. We recently started developing the first phase of Hammock Creek, a collection of 55' and 65' wide lots with homes by CraftMaster and HHHunt, and we'll be starting *Legacy Park – Phase 2* next spring. We're also under construction on Magnolia Summit Avenue, the roadway that will connect Magnolia Green Parkway with the 100- acre parcel located in the southwest corner of Magnolia Green, currently zoned for a super-senior, life plan community.

As far as our commercial properties are concerned, we have not received any offers yet for the Welcome Center building/4 acres, or the adjacent 6-acre parcel that fronts Hull Street road, but two local, restaurant owner/operators have both expressed an interest and are working to determine the improvements necessary to convert the building to a full-blown restaurant/bar. We will be completing the construction of Magnolia Market Avenue, the primary north-south roadway that serves *The Marketplace at Magnolia Green*, this summer. The roadway will provide another direct connection from Magnolia Green Parkway to Hull Street road, and will be signalized once traffic warrants have been met. The *Magnolia Academy Children's Center* is quickly nearing completion and will officially open January 3rd. With the incredible number of kids we have living in Magnolia Green, we are very excited about having a daycare center inside of Magnolia Green that also offers after-school programming. The facility will also feature a first-class gymnasium that is available to rent after school hours for birthday parties, basketball team practices, etc.

Finally, Michelle Atkins, a long-time resident of Magnolia Green and the marketing manager for iStar, has decided to step-down as the chairperson of our social committee. Michelle has helped plan and execute our community social events for over ten years and we sincerely appreciate all of her efforts in this regard. We have a great group of residents on the committee who are positioned to continue our fantastic social programming, but we are always looking for more volunteers to help out. HOA UPDATE

The HOA ensures harmony in our community. It is currently managed by Goodman Management Group, who works to enhance the value of our community. They maintain the amenities and common areas that you enjoy every day at Magnolia Green. They can provide you with guidance on the following day-to-day items:

- Trash/Recycle Pickup- contact HOA to request delivery of your trash/recycle bin. Community trash and recycling pick-up is on Tuesdays.
- Once you close on your home, apply for resident Photo ID's. These are required for use of our amenities. Proof of residency (driver's license) is required to receive your pass.
- Payment of Association Assessments you must be current on your quarterly dues to be granted access to amenities. HOA assessments are due the 1st of January, April, July and October. The Goodman Management Group app is the most efficient way to access your account and pay your dues. To sign up, complete the registration process using your full name, address, and account number that was sent in your welcome letter. The app is available at your iPhone or Android app store or you can go to www.gmgva.com.
- Architectural Review Board you must submit an application for approval on any proposed exterior modifications to the home, yard or landscaping, prior to their implementation. Applications and all supporting documents must be submitted at www.gmgva.com.






