From the desk of Tom Page...

As most of you know, the County Board of Supervisors recently approved the rezoning for the upper Magnolia Green property to facilitate the development by the County Economic Development Authority of a Technology Village west of the future Powhite Parkway, and a middle school, high school, and some residential development east of the Parkway. I know some folks were opposed to the rezoning, but I believe the long-term benefits will be substantial, including job growth in our area, and most importantly, the project will accelerate the funding and construction of the Powhite Parkway extension down to Hull Street road. When completed, the Parkway will not only provide the residents of Magnolia Green a direct access to downtown Richmond, where many of you work, but will also remove a significant amount of traffic from the heavily congested Hull Street road.

From a new home sales standpoint, we are seeing a slight slowdown compared to the previous two years, but still fairly strong with 76 homes sold year-to-date. In Phase 3, we are sold out of Hampton Pointe and Forest Hills, and will be sold out shortly in, Banyan Cove and Legacy Park.

Our lot inventory is much improved, and will be getting better, as the 50 lots in **Charleston Club – Phase 3**, a continuation of our age-targeted product, is now complete, along with the 19 lots in **Hammock Creek**, a collection of 55' and 65' wide lots with homes by CraftMaster Homes and HHHunt Homes. **Glen Abbey – Phase 2** will be complete the middle of June, and we are underway with the development of **Meridian Phase 1**, a continuation of Ryan Homes **Hampton Pointe** product line, and **Palisades Cove – Phase 2**, HHHunt Homes townhome product. We will be starting the development of **Legacy Park – Phase 2** shortly, which includes sixty-seven lots and homes by CraftMaster Homes and LifeStyle Home Builders.

Interest in our commercial parcels remains limited, but we expect activity to increase as both Magnolia Green, and the surrounding area, continues to grow. Construction of our new elementary school, **Moseley Elementary**, is nearing completion and a ribbon-cutting ceremony is scheduled for Monday, July 25th at 9 am. If you're interested in volunteering at the school, this might be a great opportunity to meet principal Karen Dubiel and show your support for the **Mustangs!**

Finally, I'd like to give a shout out to the management team at the golf club for delivering two incredible events over the last several weeks. The first event played host to over 200 real estate agents from the **Richmond Association of Realtors**, and the second was the Darrell Green Celebrity tournament that raised a record \$115,000 for his charity, Youth Life Foundation of **Richmond**. The success of the golf club is critical to the long term health of our community, and I encourage everyone to support the club. Please remember, the club is semi-private, meaning everyone is welcome to play or simply enjoy a lunch or dinner.

HOAUPDATES

Summer is here, and the pool season is in full swing!

Just a friendly reminder that you must show your new Photo ID Card to have access to both the Aquatic Center and Arbor Walk pools. You should also carry it with you whenever using any of our common areas (basketball courts, volleyball, tennis courts, etc.). If you do not have it, you will not be permitted to use any of the amenities or common areas. If you have not obtained a new Photo ID Card, please log onto your account at **www.gmgva.com** and follow the directions on the Amenity Pass tab.

Please be advised that trash dumpsters located at Arbor Walk, the Aquatic Center, the Tennis Center, and Charleston Club are not for disposing of any homeowner debris or trash. These are strictly for trash generated at each facility.

If you see something, say something! Please remember that the Chesterfield Non-Emergency Police phone number is **804-748-1251.** If you see a situation where the law is potentially being broken, we encourage all homeowners to call this number immediately, followed by a call or email to the HOA.

Please remember that payments for the 3rd Quarter are due on **July 1st.** If you're already signed up for direct debit payment with the Goodman Management Group, then your dues will be automatically drawn on July 5th. All homeowners should log on to their account at **www.gmgva.com** and check their account information to see how much is due as well as find payment options.

The annual window washing, gutter cleaning, and power washing services for Valhalla and Wynstone Park, as stated in the Supplemental Declarations, will be conducted in July! Valhalla is scheduled for July 11-13, while Wynstone Park is scheduled for July 13-20. Please remove all lawn ornaments and outside patio furniture in preparation for this service.

Property Improvements/Modifications

In Magnolia Green, all improvements or modifications to the exterior of the home, or the lot/landscape, require approval by the Architectural Review Committee ("ARC"). The HOA has contracted with an independent, licensed architectural firm to function as the ARC, whose responsibility is to ensure the proposed improvements are in conformance with the design standards adopted for that particular neighborhood. The design standards for your neighborhood can be found at gmgva.com, under documents. Fees are charged for the review/approval process and they will vary depending upon the type of modification requested.

Please note that any exterior modification to the home or lot must be approved in writing by the ARC prior to starting any work. Work started or completed prior to approval by the ARC is subject to removal if after plans have been submitted and reviewed by the ARC, any addition or improvement is deemed to be not in compliance with the standards.

A community-wide email was recently sent to provide detailed information and instructions on how to submit an application for your home and property improvements. If you have not signed up for email alerts, please do so at your earliest convenience.
