

From the desk of Tom Page...

The incredible residential sales market we experienced over the last 2 years, which was driven by historically low mortgage interest rates and the exodus of folks from the large cities in the northeast relocating to the mid-atlantic area, appears to be over and we are now settling back into a more normal market. In normal conditions, new home sales are driven by two factors; job growth which brings young executives and their families to our area, and the relocation of the grandparents to our area who want to be close to the grandkids. Chesterfield County continues to create new jobs, highlighted recently by the one billion dollar Lego plant to be built at Meadowville Landing, and with the zoning approval of the Upper Magnolia Green project, I believe other large projects that create jobs will be forthcoming in the near future.

From a new home sales standpoint, traffic visiting the project and our model homes continues to remain fairly strong, but sales have slowed as the rising interest rates, now at 7%, combined with inflation driving up the cost to build new homes, has priced some folks out of the market. We currently stand at 115 new home sales, but will most likely fall short of our goal of 190 sales for the year.

Our lot inventory is at an all-time low of only 51 completed and unsold lots, but this will improve dramatically over the next several months as we are working diligently to complete the following neighborhoods; **Meridian Phase 1,** a total of 55 lots and a continuation of Ryan Home's **Hampton Pointe** product line, will come on-line in November. **Palisades Cove – Phase 2,** 59 more lots of HHHunt's townhome product, will be complete around the end of the year, and **Legacy Park – Phase 2,** which includes sixty-seven lots and homes by CraftMaster and Lifestyle, will be complete early next year.

Interest in our commercial parcels remains limited, but we have had some positive discussions with a local medical group looking to construct a 40,000 sf office building in our area. Once again, **Dog-A-Pool-Ooza**, our annual social event that allows you to bring Fido to enjoy the Arbor Walk pool with his canine friends for an afternoon, was a huge success. Not only did the dogs have a great time, but \$500 was raised for Sanctuary Rescue.

Finally, I love to play golf but rarely get the chance to play our course because I'm so busy with the day-to-day management of Magnolia Green. However, I was fortunate enough to play in the Richmond Region Tourism tournament a couple weeks ago and a great time was had by all. Kudos to the golf club management team, as the course was in great condition, the food and drinks were excellent, and the overall event ran smoothly. HOAUPDATES

Reminders:

The holidays are just around the corner, be sure to review the community rules regarding decorations and lighting. Be courteous of your neighbors.

"Holiday/Seasonal Decoration" as used herein means those temporary decorations and lighting associated with a particular national, state, local or religious holiday. Holiday/Seasonal Decorations may be displayed without ARC approval for up to seven (7) days before and seven (7) days after such holiday, except Christmas and Hanukkah decorations which may be displayed from Thanksgiving through January 7th of each year. Owners desiring to display Holiday/Seasonal Decorations for longer periods should apply to the ARB for permission. Owners are urged to take care and exhibit consideration for their neighbors when displaying Holiday/Seasonal Decorations so as not to cause an unreasonable source of annoyance to occupants of neighboring property. Excessive inflatable displays are prohibited.

Please be reminded that trash dumpsters located at Arbor Walk, the Aquatic Center, the Tennis Center, and Charleston Club are not for disposing of any homeowner debris or trash. These are strictly for trash generated at each facility.

If you see something, say something! Please remember that the Chesterfield Non-Emergency Police phone number is **804-748-1251.** We encourage all homeowners that see any suspicious activity to call this number immediately, followed by a call or email to the HOA.

Property Improvements/ Modifications

In Magnolia Green, all improvements or modifications to the exterior of the home, or the lot/landscape, require approval by the Architectural Review Committee ("ARC"). The HOA has contracted with an independent, licensed architectural firm to function as the ARC, whose responsibility is to ensure the proposed improvements are in conformance with the design standards adopted for that particular neighborhood. The design standards for your neighborhood can be found at gmgva.com, under documents. Fees are charged for the review/approval process and they will vary depending upon the type of modification requested.

Please note that any exterior modification to the home or lot must be approved in writing by the ARC prior to starting any work. Work started or completed prior to approval by the ARC is subject to removal if after plans have been submitted and reviewed by the ARC, any addition or improvement is deemed to be not in compliance with the standards.

A community-wide email was recently sent to provide updated information and instructions on how to submit an application for your home and property improvements. If you have not signed up for email alerts, please do so at your earliest convenience.

Once your registration is approved, you will be able to make your quarterly assessment payment, download community documents, submit and view work order requests, submit architectural modification requests, view the community calendar, stay up-to-date on community events, and much more! 


